THTA is a member of the **Joint Foreign Chambers of Commerce (JFCCT)** which has 34 chambers of commerce and business associations representing over 9,000 companies in this wide membership. The mission of JFCCT is to promote trade and foreign investment, encourage skills development and transfer with the overall aim of contributing to the economy. JFCCT groups all the power of the foreign communities in order to have more negotiation power with Thai Government. There is a number of specialists Committee group in JFCCT such as Education & Skills, Employment, ICT, International Trade, Tourism and SME and THTA have the representative in these JFCCT Committees.

Besides, THTA is also the member of the **Board of Trade of Thailand** (BOT) which supports their members for the following tasks.

- 1. Cooperation with Governmental Sector in relation to Economic and Trade Development
- 2. Supporting and Promoting Business Operations of the Private Sector
